

2024 Pool & Spa Maintenance Service Agreement

We hereby propose to provide pool and spa service at the above address. Each visit will consist of:

- Vacuuming & skimming as necessary
- Cleaning & emptying of baskets
- Brushing of tile /water line
- Testing water & adding chemicals

- Cleaning filter as necessary
- Checking equipment
- Cleaning automatic cleaner bag
- General area clean up

Drain & Cleans of the spa will be scheduled as necessary by your technician. Each drain and clean will be billed at \$250.00. You will be given at least a week notice per occurrence

The following terms and conditions apply to the service:

- 1. <u>Safety Issues</u>: The customer is responsible for maintaining local code compliance regarding safety issues including, but not limited to, decks, fencing, gates, electrical, etc.
- 2. <u>Water Level:</u> We will add water while on site if needed and will turn it off when we leave. It is the homeowner's responsibility to maintain proper water level.
- 3. <u>Chemicals:</u> All chemicals are provided by Arvidson Pools & Spas at additional cost. These include, but are not limited to, sanitizer, balancing chemicals, algaecide, & cleaners. It is the homeowner's responsibility to maintain proper chemistry unless you are a weekly maintenance customer.
- 4. <u>Cancellation / Rescheduling</u>: In the event you need to cancel or reschedule your weekly service, please notify us via phone (815) 459-0660 Ext 113 or Email (Servicerequest@Arvidsons.com) at least 24 hours in advance to avoid a \$50 trip charge.. If for some reason you need to cancel the service, we require a one week written notice.
- 5. <u>Pets:</u> It is the homeowner's responsibility to contain and restrain their pets whenever a service technician is on the property or service will not be performed..
- 6. Equipment / Pool and Spa Repairs: We will contact you directly if our technician notices an issue with your pool or spa. Please note we only troubleshoot and repair Watkins branded spas. All other brands will require an alternative repair company. If you notice a problem with your system prior to our next scheduled stop, please contact us immediately. Once the repair is authorized by you, we will dispatch the next available technician to your residence. You will receive top priority scheduling.
- Customer Satisfaction: Our goal is your complete satisfaction. In the event that a job is not satisfactorily completed, please notify "ZZ" Johnson, Service Manager, within 48 hours, so that we can look into the matter and resolve it quickly. If you do not bring the issue to our attention, we cannot correct the situation and consequently will not issue any credits.
